- Lead and supervise all store personnel to allocate materials against each job/drawing following agreed priority, to material controllers to issue materials to each supervisor, monitor materials, and ensure surplus materials are promptly returned to Stores and properly accounted for.
- Led the function to collect/receive Client free issue materials and Madina bought out materials, unloaded, and stacked, following inward goods inspection, mark-up the MCN (Lot Number) / Job number/quarantine non-conforming materials, and resolved non-conformances with Client/supplier in conjunction with QC Inspectors.
- Ensure free issue (client-issued) materials if any are delivered/issued to subcontractors on time, and receive and inspect products delivered by subcontractors.
- Ensure through material controllers that all tools accessories and consumables in Stores are properly accounted for, properly preserved, and stored such that they are easily retrieved.
- Notify the Materials Manager of any changes/variations in materials that have a price impact (e.g. Madina materials are used instead of Client-free issue materials, machining is done to resolve non-conformances, etc.)
- Review the stock material and provide MRP including stock items, consumables, tools and accessories, and PPE, ensuring in conjunction with Purchaser that they are received following the agreed schedule.



- Assist with the feedback on the supplier's performance on the timely delivery, quality concerns, and safety concerns for periodical assessment.
- Strong functional knowledge of procurement, sourcing, and ERP tools with the ability to generate spreadsheets and presentations.
